General Terms

Beyond the processing of my data within the scope of photographs/videos in accordance with my consent to the processing of personal data pursuant to UK GDPR, I hereby agree that CGLMC Ltd and its affiliates and representatives ("CGLMC") the worldwide, irrevocable, if not otherwise stipulated royalty-free, assignable, sublicensable and exclusive rights to use my name, image, likeness, appearance, voice, professional and personal biographical information, produced and planned statements, interviews and recordings of me for advertising purposes. I am aware that, in regard of the processing of my personal data, the provisions of my consent to the processing of personal data pursuant to UK GDPR shall apply, unless otherwise explicitly regulated in this declaration. Recording shall mean any image, video, audio or other recording stored in or on any optical storage medium, magnetic storage medium, electronic memory, or any tangible medium of expression, as currently exists or which becomes available in the future.

The transfer of the above rights to CGLMC, its Affiliates and agents, shall include the rights to copy, modify, have modified, reproduce, have reproduced, distribute, have distributed, digitize, publicly perform, broadcast, transmit or replay the Recording, or any modification of the Recording or derivative work of the Recording. The Recording, statements and interviews may be used in digital form and analogue form in all suitable media (e.g. printed publications, magazines, newspaper, television, radio, internet, cinema, theatre) and stored in databases or in other data structures, even if such data structures are accessible online. The mention of names shall be left to the discretion of CGLMC. This promotional release will be valid anywhere and at any time.

Consent to the processing of personal data pursuant to UK GDPR: I hereby agree that CGLMC Ltd and its affiliates and representatives ("CGLMC") collect and process my personal data for the purpose of showcasing my photograph or video. CGLMC keeps my personal data for these purposes for the duration of 4 years, unless CGLMC is entitled or obliged to store personal data for a longer period of time due to other agreements or statutory provisions.

CGLMC may also share my personal data with independent third-party companies that CGLMC engaged for these purposes. CGLMC may also transfer my personal data to countries outside the European Economic Area (EEA), such as the United States of America, which have different, and less protective data protection laws. But, where the latter is the case, CGLMC relies on admissible data transfer mechanisms, such as Standard Contractual Clauses, Binding Corporate Rules or the US recipient's Privacy Shield certification, if any. I am aware that affiliates shall mean any entity that controls, is controlled by, or under the common control of CGLMC, where control is established by majority ownership of the voting equity securities of the controlled entity.
